1.0 Introduction

1.1 Details of the Organization

Pertubuhan Peladang Kawasan Negeri Sembilan of 6 estates located within Seremban, Johol, Tampin, Jempol, Rembau & Lenggeng. Pertubuhan Peladang Kawasan Sri Klana Lenggeng is the group manager and Haji Muhammad Nasri Bin Yaakub is the person in charge (as the group manager). Based on the sampling calculation in AUDIT PROCESS — Calculation of Sample Size, 4 estates are selected randomly to be involved directly (documentation review and site visit) during the MSPO Initial Certification Stage 2 Audit for the group. The 4 estates are:

- 3. Pertubuhan Peladang Kawasan Sri Klana

2.0 Audit Process

2.1 Audit Objectives

The objectives of the audit are to verify the management system conforms with all the requirements of the MSPO standards and that the organization has effectively implemented the planned MSPO management system as well as to check if the management system can achieve the organization's policy objectives.

2.2 Audit Methodology

The MSPO initial certification audit was done in two stages – Stage 1 and Stage 2. For Pertubuhan Peladang Negeri Sembilan, Stage 1 audit was conducted on 02 July 2020 and Stage 2 on 20-21 October 2020 in Negeri Sembilan, Johor. Stage 1 Audit was conducted mainly to review documents and to check area of concerns as to see how ready the estate is to go for Stage 2. During Stage 2 Audit, the audit team had visited 4 estates (See 1.1 Details of the Organization) to check facilities and structures available such as site office, workers' quarter and storage area. The team also did site inspections to see the operational site of the estate such as road maintenance, terracing on steep areas, cover crop maintenance, any natural stream or waterway, block maintenance (spraying, manuring and fronts stacking) as well as the estate boundary to verify the implementation of the MSPO (MS2530-3:2013) Part 3: General Principles for Oil Palm Plantations and Organized Smallholders. Interviews were carried out with the team management, employees, contractors and other relevant stakeholders. Documents and records verification was also done to further support and validate findings from Stage 1 audit.

The methodology for collecting objective evidence are physical site inspection, observation of tasks and processes, interviews with management, employees and workers, consultations with contractors and stakeholders as well as documents review and data monitoring. The audit evidence obtained were based on samples of information available; thereby introduces the element of uncertainty.




Figure 1: Location of all the 6 estates in the group based on GPS points in Google Map.
