Introduction

Jorak Land Estates (will be referred as **JLE** in the finding section, **APPENDIX A**) is a group of 3 independent estates owned and managed by the same entity. 2 of the estates are located within the district of Muar in Johor and the other 1 is within the district of Alor Gajah in Melaka. The group was MSPO certified in November 2020.

In the initial year of certification, the estate consisted of only 2 estates. For this surveillance audit, another estate will be included which was acquired by the company which was already MSPO by another certification body. The total area of land to be certified in this surveillance audit is 223.56 Ha with 213.85 Ha is planted with oil palms.
