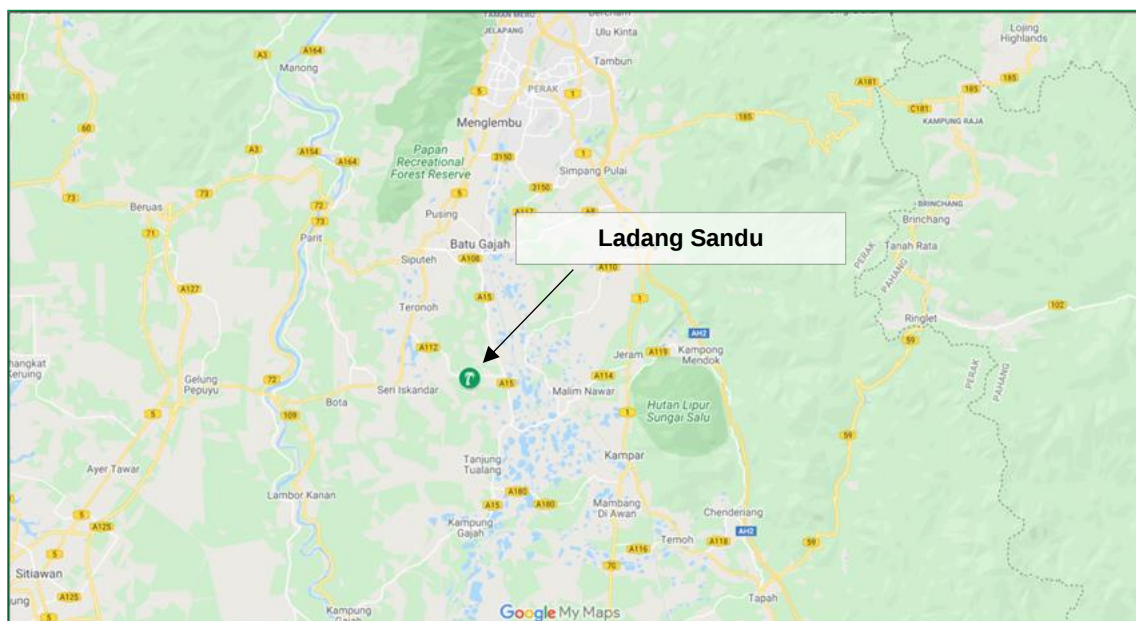


Figure 1: Location of Ladang Sandu in Google Map based on its GPS coordinate
