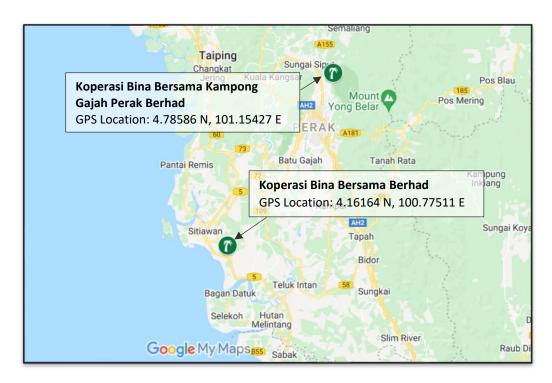


Figure 1: Location both estates in Google Map based on its GPS coordinate
