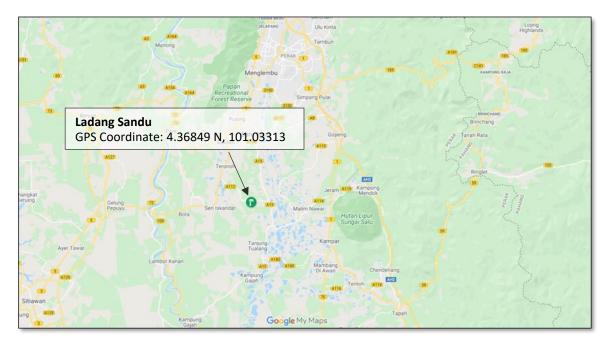


Figure 1: Location Ladang Sandu in Google Map based on its GPS coordinate
