Thangamallay Estate (TME) is located in Mukim Duabelas and Mukim Klang within the district of Kuala Langat and Klang. The estate covers a total of 262.5 Ha of land and currently about 216.63 Ha is planted with oil palms. Crops from Thangamallay Estate are supplied to Seri Bandar Palm Oil Mill.

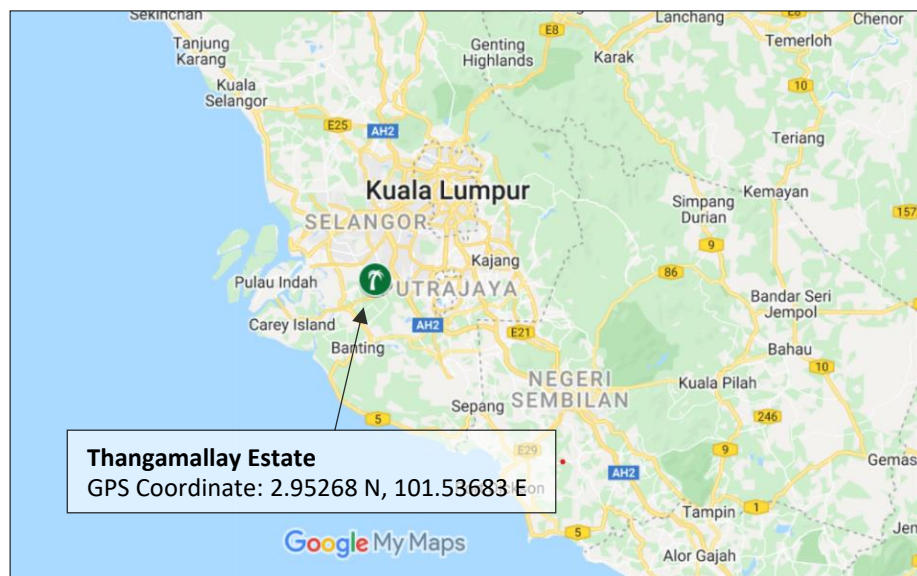


Figure 1: Location **Thangamallay Estate** in Google Map based on its GPS coordinate
