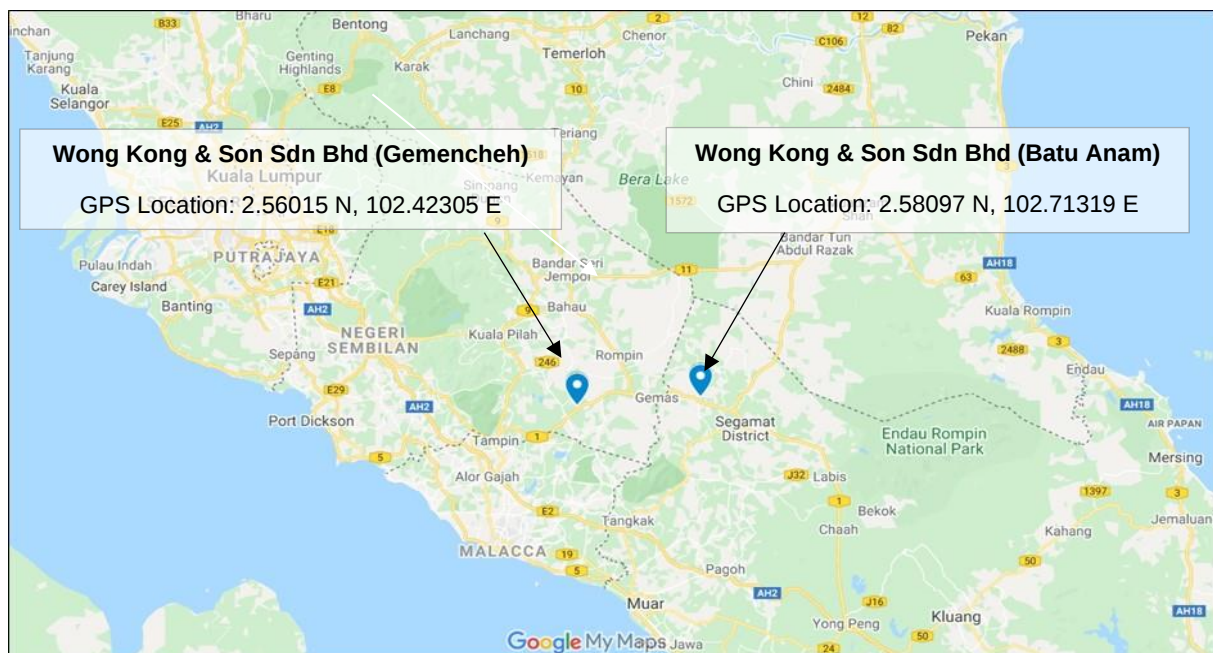


Figure 1: Location of **Wong Kong & Son Sdn Bhd** in Google Map based on its GPS coordinate
