DETAILS OF CERTIFIED UNIT

Background

Angtong Estates Sdn Bhd (will be mentioned as AESB in the finding section) is a Malaysian Sustainable Palm Oil (MSPO) Standard certified fresh fruit bunches (FFB) producers for their oil palm estates in Johor, Malaysia. In the previous audit, the group was called Mixed Holding Pte Ltd, but the name was changed to Angtong Estates Sdn Bhd in 2020.

The company has appointed ECCO Certified Sdn Bhd to conduct the company's MSPO Annual Surveillance Audit –Year 1 (ASA-1). The initial certification process was carried out by Global Gateway Certifications (GGC) Sdn Bhd and their first MPSO certificate was issued on 21 October 2019.

AESB consists of 2 certified units –Mixed Holdings Pte Ltd and Avon River Estate, located in Kota Tinggi and Mersing respectively. Mixed Holdings Pte Ltd has 2 sites –Air Tawar and Telok Sengat, both within the district of Kota Tinggi. The total area certified under MSPO for the group is 560.52 Ha.

This surveillance audit was conducted to ensure the company is still meeting the key elements of the MSPO standards requirement and to verify that all non-conformities (NC) issued in the previous audit has been closed and all corrective actions have been implemented effectively.
