Background

Oakdale Plantations Sdn Bhd (previously known as Yeng Chong Realty Bhd) is an independent palm oil plantation that was MSPO certified since June 2020. The estate is in Jasin, Melaka with a total of 369.61 Ha of land planted with palm oil. Currently the estate employs 4 local staffs, 4 local workers and 1 Indonesian. FFB from the estate is supplied to a collection centre, Sri Maju Kesang Sdn Bhd.

This surveillance audit was conducted to ensure the company is still meeting the key elements of the MSPO standards requirement and to verify that all non-conformities (NC) issued in the previous audit has been closed and all corrective actions have been implemented effectively.

Interviews are done with the management unit's management, employees, contractors and other relevant stakeholders were also conducted during the audit. The audit evidence obtained were based on samples of information available; thereby introduces the element of uncertainty.
