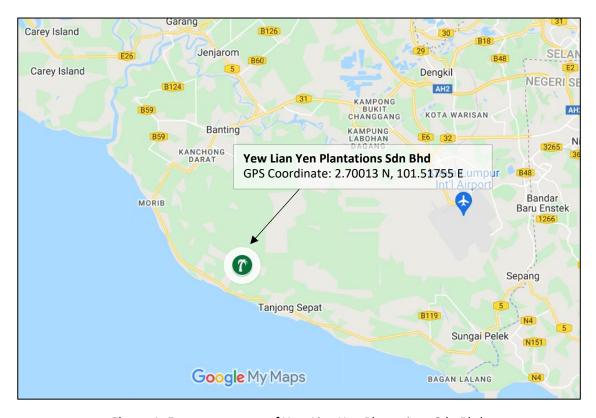


Figure 1: Estate area map of Yew Lian Yen Plantations Sdn Bhd.
