Bukit Berembun Palm Oil Mill (BBPOM) is located in Keratong within Rompin District in Pahang. BBPOM was established on 17 November 1983 under the name of Southern Leasing (M) Sdn Bhd.

On 15 June 2010, the company changed its name to Southern Keratong Plantations Sdn Bhd. BBPOM is the mill division of Southern Keratong Plantations Sdn Bhd located within Bukit Berembun Estate which occupies 11 Ha of the estate land. It has a capacity of 30 MT/hour, running in 2 shifts with a total work force of 89 locals and Indonesian workers.




Figure 1: Location of Bukit Berembun Palm Oil Mill in Google Map based on its GPS coordinate
