Background

Urun Plantations Sdn Bhd (Ladang Urun) was founded in 1995 and owned by Sin Heng Chan (Malaya) Berhad with main office in Kuala Lumpur. The estate is located in Belaga within Kapit in Sarawak with a total land bank of 10,940.50 Ha on mineral soil. Currently cultivating oil palms on approximately 4,008.80 Ha with a total of 428 workforces; a mixed of local staffs (29) and workers (80) with Indonesian workers (319). The estate supplies its crops to Sarawak Oil Palm Berhad and Belaga Palm Oil Mill Sdn Bhd. The estate is committed to sustainability through MSPO Certification which has been achieved in 2019.

This surveillance audit was conducted to ensure the company is still meeting the key elements of the MSPO standards requirement and to verify that all non-conformities (NC) issued in the previous audit has been closed and all corrective actions have been implemented effectively.
